Terms and Conditions

PROMOTION IS SUBJECT TO ALL APPLICABLE FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.

1. **AGREEMENT TO TERMS AND CONDITIONS:** Participation in the “Total Wine Wednesdays” (the “Promotion”) constitutes entrant’s full and unconditional agreement to and acceptance of these Terms and Conditions and the decisions of Administrator and Sponsor (as defined below), which are FINAL AND BINDING in all respects. TERMS AND CONDITIONS ARE SUBJECT TO CHANGE WITHOUT NOTICE. Winning a prize is contingent upon fulfilling all requirements set forth herein.
