OFFICIAL RULES

If there are multiple correct guesses, a random drawing among all correct guesses will be declared the winner. If there is no correct guess, the closest guess without going over will be declared the winner.

The time of receipt of any entry shall be the time such entry is made available to Fire via the platform. Fire computer shall be the official clock of the Sweepstakes.

Any entries that do not comply with these Official Rules and any that are removed or hidden prior to the End Date are void.
