

## 10 REBOUNDS FOR \$10 eGIFT CARD OFFICIAL PROMOTION RULES

By participating in the 10 Rebounds for \$10 eGift Card Official Promotion ("**Promotion**"), Entrants agree to abide by and be bound by these 10 Rebounds for \$10 eGift Card Official Promotion Rules ("**Rules**"), which are final and binding in all matters relating to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Force 10 Hoops LLC d/b/a "Seattle Storm" ("**Presenter**" or "**Storm**") reserves the right to interpret and apply these Rules in its sole discretion, and to modify or terminate the Promotion at any time.

### **WHO MAY ENTER**

The Promotion is open only to legal residents of the United States of America who are 18 years of age or older at the time of entry. Employees, officers, directors, members, managers, agents and their support staff, Presenter, the Women's National Basketball Association ("**WNBA**"), WNBA Enterprises, LLC ("**Enterprises**"), Starbucks Corporation and each of their respective parent companies, subsidiaries, affiliates, advertising/contest/fulfillment agencies, and anyone else connected with the production and distribution of this Promotion (hereafter, collectively, "**Released Parties**") and their immediate families (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and those living in their same household, whether or not related, are not eligible to enter or win. #### **To enter:**

Each Entry Period will begin when a Storm player reaches ten (10) confirmed rebounds during an applicable Regular Season Home Game (the "**10 Rebound Threshold**"). If and when a Seattle Storm player reaches the 10 Rebound Threshold during a Regular Season Home Game, Presenter will display a QR Code provided by [Starbucks Corporation, or a vendor thereof] that gives access to **The Prize** (\$10 Starbucks eGift Card) on the scoreboard at Climate Pledge Arena for a limited amount of time. Presenter controls the official time-keeping device for the Promotion and each Entry Period. The QR Code will direct winning fans to a landing page displaying a unique Starbucks provided URL for the \$10 Starbucks eGift Card.

Once the QR Code is displayed at Climate Pledge Arena after achieving the **10 Rebound Threshold**, the QR Code must be scanned by a mobile device to access **The Prize**. The Promotion will be divided into multiple entry periods throughout the season, up to one for each Storm Regular Season Home Game beginning May 22, 2026 and continuing until the last Storm Regular Season Home Game of each of the 2026-2027 and 2027 - 2028 WNBA basketball season (each, an "**Entry Period**").

### **PROMOTION PRIZES**

#### **Prizes:**

**The Prize** is a \$10.00 Starbucks eGift Card available via the QR Code and may be redeemed immediately upon downloading.

Number of Prizes will be determined by the number of people who scan the QR Code with a limit of 200 max per game. The total number of Prizes and winners may adjust each Regular Season Home Game.

Valid only while supplies last. Presenter and/or Sponsor may elect to terminate the Promotion at any time and from time to time, in their discretion.

The Approximate Retail Value (“ARV”) of the Prize is \$10.00.

**Limit one Prize per game, per person during each Entry Period.** The QR Code may only be used one time per person and may not be used after expiration of the Prize Term. By downloading the Prize onto an applicable Sponsor application, accessing **The Prize** online or via the Storm website (as applicable)(“**Website**”) or otherwise utilizing **The Prize** for purchase of Sponsor goods, you agree to these Official Rules.
